ARTICLES OF INCORPORATION OF AIRX AMERICA INC.

in compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be AirX America Inc. (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE
