



Enclosed please find a check in the amount of \$35.00 for the cost of a Corporate Dissolution action to the above referenced corporation. Additionally enclosed is \$137.50 for a Certificate of Domestication, Articles of Incorporation and Certified Copy, and the option Certificate of Status fee for Faith Transport Inc. to be domesticated into the State of Florida as a not-for-profit corporation. The Cover Letter, and Not For Profit Domestication form are also enclosed.

This corporation was previously domesticated on or about July 29, 2016. However, it was mistakenly domesticated as a for-profit corporation in the above referenced Document # P16000062794. Faith Transport is a religious assistance corporation that was a not-for-profit corporation in Pennsylvania. Our office contacted the Division of Corporations as to how to correct this, and we were advised to refile with a Not For Profit Domestication form and filing fee in order to clear the matter up.

We were also advised that an enclosure letter needed to accompany the documents referencing the corporate I.D. in order to advise the Department about the nature of the situation so that the Tax I.D. information and other data associated with Faith Community South, Inc. in the state's database could be preserved. This letter is for that purpose. As such, the incorrectly filed for-profit Faith Community South, Inc., needs to be dissolved, but its Tax I.D. number and other information associated with Faith Community South, Inc. needs to be preserved and transferred to the new entity to avoid confusion.
