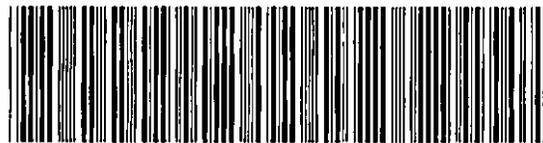

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
NOVEMBER 7, CORP.**

Pursuant to the provisions of section 607.1006, Florida Statutes, **NOVEMBER 7, CORP.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation which were filed with the Florida Department of State on July 28, 2016, having a Document Number of P16000063160.

**FIRST:** Article VII of the Articles of Incorporation of the Corporation is amended in its entirety and restated as follows:

**Article VII  
DIRECTOR AND OFFICERS**

The Board of Directors of the Corporation shall consist of three (3) Members. Changes in the number of Members comprising the Board of Directors shall be made by amendment to the Corporation's Bylaws.

Thereafter, the term of office of each Director shall be five (5) years and until the election and qualification of a successor. The number of Directors set forth herein and constituting the initial Board of Directors shall be the authorized number of Directors until such number is changed by a bylaw duly adopted by the Shareholders.

The Officers of the Corporation shall consist of President, Vice President, and Treasurer. Changes in the number of officers of the Corporation shall be made by amendment to the Corporations' Bylaws with the unanimous vote of the sharcholders.

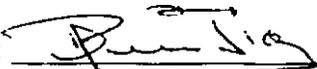
