ARTICLES OF INCORPORATION OF 2016 CHERRYGROVE CORP.

ARTICLE I - NAME

The name of this Corporation is 2016 Cherrygrove Corp., and its address is 200 South Biscayne Boulevard, Suite 4100, Miami, Florida 33131.

ARTICLE II – DURATION
