

ARTICLES OF INCORPORATION OF FORKEAT INC.

The undersigned Gene R. Moses, being over the age of eighteen years, and for the purpose of forming a corporation under the laws of the State of Florida, and in pursuance thereof does hereby sign and acknowledge the following Articles of Incorporation, in duplicate originals, and state as follows:

ARTICLE I

Corporate Name

The name of the corporation shall be Forkeat Inc.

ARTICLE II

Principal Office

The principal street address and mailing address of the corporation are:

ARTICLE III

Corporate Purpose

The general nature of the business of the corporation, and the objects and purposes proposed to be transacted, promoted and carried on by it, are as follows:

- 1. To engage in the business of creating, developing, manufacturing, and distributing software and applications for computers and mobile devices as shall from time to time be directed by the Board of Directors.
- To engage in generally and to carry on any lawful business or trade which may, in the judgment of the Board of Directors, at any time be necessary, useful and/or advantageous to this corporation.
- 3. Director Liability
