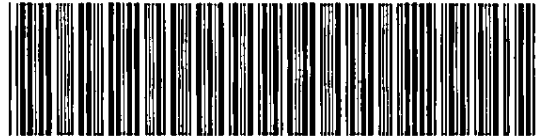

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
LAKE AREA INSURANCE AGENCY, INC.

EFFECTIVE DATE: November 10, 2020

Lake Area Insurance Agency, Inc., a Florida profit corporation (the "corporation"), by and through its undersigned sole director and shareholders, files these Articles of Amendment pursuant to Florida Statutes Section 607.1006, to be effective as of November 10, 2020.

The following amendment was adopted by the sole director and shareholders of the corporation on November 10, 2020. The number of votes cast for the amendment by the sole director and shareholders was sufficient for approval.

The text of the amendment is as follows:

"RESOLVED, that the Articles of Incorporation shall reflect the allocation of shares of issued common stock of the corporation; and

"RESOLVED, that the corporation's Articles of Incorporation as filed with the Florida Department of State shall be amended as follows for the purpose of effectuating the foregoing resolution, effective as of the effective date above:

"A new Article VIII of the Articles of Incorporation shall be added as follows:

"ARTICLE VIII

"Shareholders as of Effective Date. As of the Effective Date hereof, November 10, 2020, the current shareholders of the corporation are as follows:

"Barbara Jo Franklin and Bennie Joe Saucer, as joint tenants with full rights of survivorship, as to One Thousand (1,000) shares of common stock.

"RESOLVED, the sole director and shareholders of the corporation are authorized and directed to file appropriate Articles of Amendment with the Florida Department of State, Division of Corporations, to provide notice of the foregoing amendment."
