**ARTICLES OF INCORPORATION  
OF

**ARTICLE 1  
NAME**

The name of the corporation is SunPeak Advisors, Inc. (the "Corporation").

**ARTICLE 2  
PRINCIPAL OFFICE**

The initial Board of Directors shall consist of one (1) member whose name and address is Gregg Straus, 11251 NW 51st Street, Coral Springs, Florida 33076.


**ARTICLE 7


