The undersigned director, for the purpose of forming a successor institution in accordance with Section 658.40(4) of the Laws of the State of Florida, adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation shall be STONEGATE ACQUISITION SUB II, INC. and its place of business shall be 400 North Federal Highway, Pompano Beach, Florida 33062.

#### **ARTICLE II**
