ARTICLES OF INCORPORATION AND SEP 15 AM 8: 33

The undersigned incorporator, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name and address of this corporation shall be:

ARTICLE II - EXISTANCE

The corporation shall have perpetual existence.
