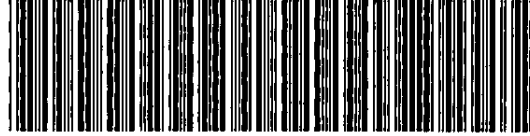

## ARTICLES OF INCORPORATION

ARTICLE I: The name of the corporation is CHISEL TECHNOLOGIES, INC. hereinafter called, "CHISEL TECHNOLOGIES, INC."

ARTICLE II: The principal place of business and mailing address of CHISEL TECHNOLOGIES, INC. is 670 NW 113<sup>th</sup> Street, Miami, FL 33138.

ARTICLE III: The purpose of CHISEL TECHNOLOGIES, INC. is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Business Corporation Act.

ARTICLE IV: CHISEL TECHNOLOGIES, INC. is authorized to issue 500,000 shares of stock. The Board of Directors is further authorized to determine or alter the rights, preferences, privileges and restrictions granted to or imposed upon any wholly unissued stock and, within the limits and restrictions stated in any resolution or resolutions of the Board of Directors originally fixing the number of shares constituting any series, to increase or decrease (but not below the number of shares of each series outstanding) the number of shares subsequent to the issuance of shares of that series.

ARTICLE V: Section 1. *Limitation of Directors' Liability.* The liability of the directors of this corporation for monetary damages shall be eliminated to the fullest extent permissible under F.S. 607.0850.


Section 2. *Indemnification of Corporate Agents.* The corporation is authorized to provide indemnification of agents (as defined in Chapter 607 of the Florida Business Corporation Act) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors or otherwise, in excess of the indemnification otherwise permitted by Chapter 607 of the Florida Business Corporation Act, subject only to the applicable limits set forth in Chapter 607 of the Florida Business Corporation Act with respect to actions for breach of duty to the corporation and its shareholders.

Section 3. *Repeal or Modification.* Any repeal or modification of the foregoing provisions of this Article V by the shareholders of this corporation shall not adversely affect any right or protection of an agent of this corporation existing at the time of such repeal or modification.
