

This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

**ARTICLE I**

The name of the corporation is **VACATION BOAT RENTALS OF THE FLORIDA KEYS, INC.**

**ARTICLE II**

The address of the initial registered offices of the corporation shall be 2532 Estero Blvd., Unit 504, Fort Myers, FL 33931 and the name of the initial registered agent for the corporation shall be Jim Figuerado, Jr., a resident of the State of Florida.

**ARTICLE III**

The mailing address of the corporation is 214 Arnold Avenue, Morristown, TN 37813 and the principal office address of the corporation is 4681 Overseas Highway, Marathon, FL 33050.

**ARTICLE IV**

The nature of the business and the objects and purpose or purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.
