**We, the undersigned, hereby associate ourselves together for the
Purpose of becoming a corporation for profit under the laws of the
State of Florida.**

ARTICLE I

The name of the corporation shall be Home Investment of Florida Inc.

ARTICLE II

**The general nature of the business and the objects and purposes
of the business proposed to be transacted and carried on are to do any
and all of the things herein mentioned, as fully and to the same extent
as natural persons might or could do, viz**

**(a) To engage in, carry on and conduct the business and the
business practices pertaining to international trade and
commerce. To establish, maintain, and operate businesses,
offices, plants, and any and all other establishments, for the
purpose aforesaid.**

**(b) To subscribe for, purchase or otherwise acquire or
become interested in, hold for investment, sell, offer for
sale, negotiate, mortgage, pledge or otherwise deal in or
with all or any part of the stocks, bonds, debentures, notes,**

evidences of indebtedness, scrip, acceptances, commercial paper, certificates of indebtedness, certificates of interest, obligations, mortgages and all other securities, rights or choices in action issued, created, assumed or guaranteed by any domestic or foreign, public, quasi-public or private corporation, firm, association, trustee, syndicate, individual, including any government, province, colony, state, district, territory, municipality or other political division or any foreign country or state, or otherwise.

(c) To apply for, purchase or in any other manner to acquire; to hold, own, use and operate; to sell or in any other manner dispose of; to grant or license other rights in respect of, and in any manner deal with, any and all rights, interests, inventions improvements and processes used in connection with or secured under letters patent or copyrights of the United States or other countries or otherwise, and to work, operate, or develop the same.

(d) To purchase, lease, or otherwise acquire, and to hold, own, sell or dispose of real and personal property of all kinds and undertakings, shares of stock, mortgages, bonds, debentures and other securities, merchandise, book debts and claims, trade marks, trade names and any interest in real or personal property.

(e) To borrow money for its corporate purposes, and to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time, for the purchase of property, or for any purpose in or about the business of the corporation and, if deemed proper, to secure the payment of any such obligations by mortgage, pledge, deed or trust or otherwise.

(f) To acquire and take over a going concern and thereafter to carry on the business of any person, firm or corporation engaged in any business which this corporation is authorized to carry on, and in connection therewith to acquire the goodwill and all or any of the assets, and to assume or otherwise provide for all or any of the liabilities of any such business.

(g) To sell, improve, manage, develop, lease, mortgage, dispose of or otherwise turn to account or deal with all or

any part of the property of the corporation.

(h) To carry on business at any place or places within the jurisdiction of the United States and in any and all foreign countries, and to purchase, hold, mortgage, convey, lease or otherwise dispose of any deal with real and personal property at any such place or places.

(i) To enter into, make, perform and carry out contracts of every sort and kind which may be necessary or convenient for the business of the corporation or business of a similar nature, with any person, firm, corporation, private, public, and municipal body politic under the Government of the United States, or any state, territory or colony thereof, or any foreign government, so far as, and to the extent that the same may be done and performed by corporations organized pursuant to Florida law.

(j) To do all and everything necessary, suitable or properly for the accomplishment of any of the purposes, the attainment of any of the objects, or the furtherance of any of the powers hereinbefore set forth, either alone or in connection with other corporations, or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid objects, purposes or powers or any of them.

stockholder or creditor thereof, or to any other person, for any loss incurred by it under or by reason of any such contract or transaction; nor shall any such director or directors be accountable for any gains or profits realized therefrom; always, provided, however, that such contract or transaction shall be at the time at which it was entered into, have been a reasonable one to have entered into, and shall have been upon terms that were at the time fair.

ARTICLE XI

The officers of this corporation shall be a President, a Vice-President, a Secretary-Treasurer, and such other offices and agents as may be deemed necessary.
