ARTICLES OF INCORPORATION

OF

ALPHASTAFF ASO, INC.

ARTICLE I

The name of the Corporation is AlphaStaff ASO, Inc. (the "Corporation").

ARTICLE II PRINCIPAL ADDRESS AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is 800 Corporate Drive, Suite 600, Fort Lauderdale, Florida 33334.

ARTICLE III PURPOSE

The purpose for which the Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act (the "Act").

ARTICLE IV DURATION

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE V CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of common stock, with a par value of \$0.01 per share.

All voting powers of this corporation shall be vested in the common stock above designated.

ARTICLE VI BOARD OF DIRECTORS

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. ARTICLE VII REGISTERED OFFICE AND AGENT

ARTICLE VIII INDEMNIFICATION

A director or officer of the Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director or officer, except for liability (i) for any breach of the director's or officer's duty of loyalty to the Corporation or its shareholders, (ii) for acts or emissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 607.0834 of the Act as the same exists or hereafter may be amended, (iv) for violation of a criminal law, unless the director or officer had reasonable cause to believe his conduct was lawful or had no reasonable cause to believe his conduct was unlawful or (v) for any transaction from which the director or officer derived an improper personal benefit.

The Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

ARTICLE IX
