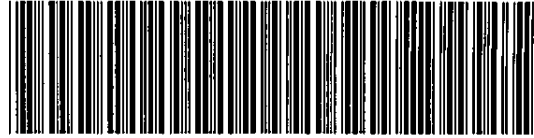

Article I - Name

The name of this corporation is VELGUMAR CORP.

Article II - Duration

This corporation shall have perpetual existence, commencing on

Article III - Purpose

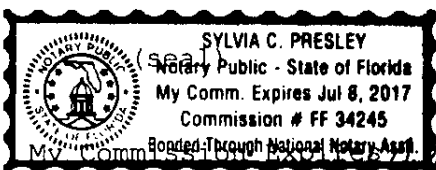
