## ARTICLES OF AMENDMENT NKA FIDUCIARY, INC.

NKA Fiduciary, Inc., a Florida corporation, hereby amends its Articles of Incorporation by adopting these Articles of Amendment, as follows:

1. The present name of the Corporation prior to adoption of these Articles of Amendment is NKA Fiduciary, Inc.
2. The Articles of Incorporation filed on 30 September 2016, effective 23 September 2016, are amended such that, as amended, Article One shall hereafter read as follows:

### ARTICLE I

The name of the corporation is NKA Fidu, Inc.

3. The foregoing amendment was adopted on 18 June 2018 by unanimous written consent of all Directors and Shareholders of the Corporation; there was only one voting group entitled to vote thereon and the number of votes cast for the amendment by the shareholders were sufficient for approval.


