## ARTICLES OF AMENDMENT YKA FIDUCIARY, INC.

YKA Fiduciary, Inc., a Florida corporation, hereby amends its Articles of Incorporation by adopting these Articles of Amendment, as follows:

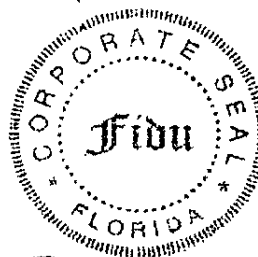
1. The present name of the Corporation prior to adoption of these Articles of Amendment is YKA Fiduciary, Inc.
2. The Articles of Incorporation filed on 30 September 2016, effective 23 September 2016, are amended such that, as amended, Article One shall hereafter read as follows:

### ARTICLE ONE: NAME

The name of the Corporation is YKA Fidu, Inc., and its principal office address is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

3. The foregoing amendment was adopted on 18 March 2018 by unanimous written consent of all Directors and Shareholders of the Corporation; there was only one voting group entitled to vote thereon and the number of votes cast for the amendment by the shareholders were sufficient for approval.
4. This amendment shall be effective upon the filing of these Articles of Amendment with the Florida Department of State.
