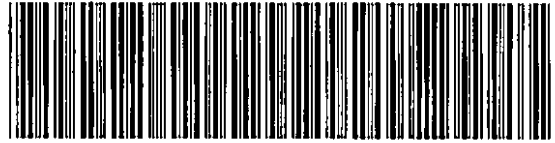




Corporate Resolution of Certified Roof Solutions, Inc.
