#### ARTICLES OF INCORPORATION

## ARTICLE I NAME

The name of the Corporation is New Harbour North America Holdings Inc. (the "Corporation").

# ARTICLE II PRINCIPAL ADDRESS AND MAILING ADDRESS

# ARTICLE III PURPOSE
