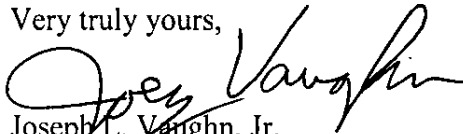

In compliance with Chapter 607, Florida Statutes, the undersigned acting as incorporators hereby adopt and file the following Articles of Incorporation for the purpose of organizing a corporation.

**ARTICLE I  
NAME**

The name of the Corporation is: **MATTHEW 7:25, INC.**

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

DURATION**

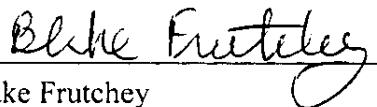

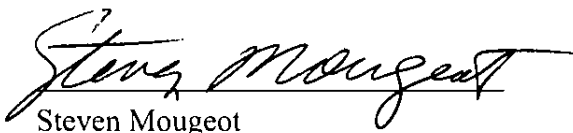

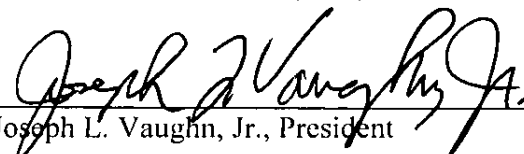
