

The undersigned person, acting as incorporator of a Corporation in compliance with Chapter 607 and/or Chapter 621 of the Statutes of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of this Corporation is WARAO TECHNOLOGIES INC.

ARTICLE II INITIAL PRINCIPAL OFFICE

The Purpose of the Corporation is to engage in any and all lawful business.

ARTICLE IV SHARES

The total number of shares which the Corporation shall have authority to issue is 10,000,000 shares of \$0.01 par value common stock (the "Stock"), as follows: (i) 5,100,000 shares of Class A Common Stock, \$0.01 par value per share ("Class A Common Stock"); (ii) 3,000,000 shares of Class B Common Stock, \$0.01 par value per share ("Class B Common Stock"); and (iii) 1,900,000 shares of Class C Common Stock, \$0.01 value per share ("Class C Common Stock").

The following is a statement of the designations and the powers, privileges and rights, and the qualifications, limitations or restrictions thereof in respect of each class of capital stock of the Corporation.

Class A Common Stock

<u>Voting</u>. The holders of the Class A Common Stock are entitled to one vote for each share of Common Stock held at all meetings of stockholders (and written actions in lieu of meetings); <u>provided</u>, <u>however</u>, that, except as otherwise required by law, holders of Class A Common Stock, as such, shall not be entitled to vote on any amendment to the Articles of Incorporation that relates solely to the terms of Class B Common Stock or Class C Common Stock if the holders of such affected

classes are entitled, either separately or together with the holders of one or more other such series, to vote thereon pursuant to the Articles of Incorporation or pursuant to Florida Law. The number of authorized shares of Class A Common Stock may be increased or decreased (but not below the number of shares thereof then outstanding) by the affirmative vote of the holders of shares of capital stock of the Corporation representing a majority of the votes represented by all outstanding shares of capital stock of the Corporation entitled to vote. Class A Common Stock shall further be eligible to vote on the election of the Board of Directors, and shall specifically choose the number of Director set forth in the Bylaws of the Company.

<u>Dividends</u>. The holders of Class A Common Stock shall receive a dividend as declared by the Board of Directors in its sole and absolute discretion and as approved by the majority of the Corporation's shareholders that are eligible to vote, in equal per share proportion to Class B Common Stock and Class C Common Stock for each share of stock held by such holder.

Class B Common Stock.

Voting. The holders of the Class B Common Stock are entitled to vote their shares of Common Stock in any meeting of stockholders (or written actions in lieu of meetings); provided, however, that, except as otherwise required by law, holders of Class B Common Stock, as such, shall not be entitled to vote on any amendment to the Articles of Incorporation that relates solely to the terms of Class A Common Stock or Class C Common Stock if the holders of such affected classes are entitled, either separately or together with the holders of one or more other such series, to vote thereon pursuant to the Articles of Incorporation or pursuant to Florida Law. The number of authorized shares of Class B Common Stock may be increased or decreased (but not below the number of shares thereof then outstanding) by the affirmative vote of the holders of shares of capital stock of the Corporation representing a majority of the votes represented by all outstanding shares of capital stock of the Corporation entitled to vote. The holders of the Class C Common Stock are not entitled to vote their shares of Common Stock in any meetings of stockholders (or written actions in lieu of meetings); provided, however, that, except as otherwise required by law, holders of Class C Common Stock, as such, shall be entitled to vote on any amendment to the Articles of Incorporation that relates solely to the terms of Class C Common Stock if the holders of such affected class are entitled, either separately or together with the holders of one or more other such series, to vote thereon pursuant to the Articles of Incorporation or pursuant to Florida Law. The number of authorized shares of Class C Common Stock may be increased or decreased (but not below the number of shares thereof then outstanding) by the affirmative vote of the holders of shares of capital stock of the Corporation entitled to vote. Class C Stock shall be ineligible to vote on the election of the Board of Directors.

<u>Dividends</u>. The holders of Class C Common Stock shall receive a dividend as declared by the Board of Directors in its sole and absolute discretion and as approved by the majority

of the Corporation's shareholders that are eligible to vote, in equal per share proportion to Class A Common Stock and Class B Common Stock for each share of stock held by such holder.
