# STATE of FLORIDA 2021 OCT 18 AH 10: 15 ARTICLES of AMENDMENT TO THE ARTICLES OF INCORPORATION of WARAO TECHNOLOGIES INC. FALL AHASSEE OF THE STATE O

Pursuant to Fla. Stat. 607.1006. Florida For Profit Corporation <u>WARAO TECHNOLOGIES</u> <u>INC.</u>, Florida Doc. No. <u>P16000083431</u>, hereby adopts the following Amended and Restated Articles of Incorporation:

- 1. The name of this Corporation is WARAO TECHNOLOGIES INC.
- 2. The text of the amended Articles is as follows:

### ARTICLE IV SHARES

The total number of Shares which the Corporation shall have authority to issue is 20,000,000 with a par value of \$0.01 per Share, subject to the terms and restrictions set forth below:

- A. The total number of shares which the Corporation shall have authority to issue is 20.000,000 shares of \$0.01 par value common stock (the "Common Stock").
- B. Subject to limitations set forth in the Shareholders' Agreement, the following is a statement of the designations and the powers, privileges and rights, and the qualifications, limitations or restrictions thereof in respect of the Common Stock of the Corporation.
  - I. <u>Voting</u>. The holders of Common Stock are entitled to one vote for each share of Common Stock held at all meetings of Shareholders (and written actions in lieu of meetings). The number of authorized shares of Common Stock may be increased or decreased (but not below the number of shares thereof then outstanding) by the affirmative vote of a Super Majority of the Shareholders (The Term "Super Majority" is defined in the Shareholder Agreement). Common Stock shall further be eligible to vote on the election of the Board of Directors.
  - II. <u>Dividends</u>. The holders of Common Stock shall receive a dividend as declared by the Board of Directors in its sole and absolute discretion and as approved by the Super Majority of the Corporation's Shareholders, in equal per share proportion for each share of stock held by such holder. The Board shall declare dividends on a quarterly basis commencing 6 months from the date of operations.
    - 3. The amendment set forth above was adopted effective as of September 20th, 2021.
    - 4. Shareholder action was required for adoption of the amendment and written consent therefor and written consent therefor was given in accordance with Fla. Stat. 607.0704.

5. The Amendment was approved by the Shareholders of the Corporation. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
