ARTICLE  
I  
NAME

The undersigned subscriber to these articles of incorporation, being duly licensed to 111DA practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I.  
NAME**

The name of the professional service corporation is Steve Tenace, Architect, P.A.

**ARTICLE II.  
PRINCIPAL OFFICE**

The principal office and mailing address of this corporation are 3978 Grove Park Drive, Tallahassee, FL 32311.

**ARTICLE III.  
PURPOSE**

The professional service corporation is formed to engage in every phase and aspect of the practice of Architecture. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

It is intended that this professional service corporation shall be an "S Corporation" as defined in Section 1361(a) of the Internal Revenue Code. This professional service corporation shall have all powers as are permitted by applicable law and not inconsistent with its status as an "S Corporation" and as a professional service corporation.

**ARTICLE IV.  
TERM OF EXISTENCE**

The professional service corporation shall have perpetual existence starting on the date these articles of incorporation are filed with the Florida Department of State.

**ARTICLE V.  
CAPITAL STOCK**

The capital stock of the professional service corporation shall be 1000 shares of common stock. All shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon matters on which shareholders have the right to vote. There shall be no more than thirty-five shareholders in this Corporation.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice architecture in the State of Florida.

**ARTICLE VI.

AMENDMENT**

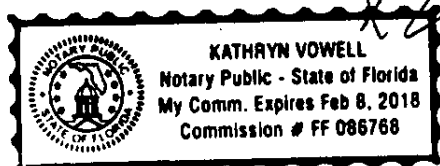

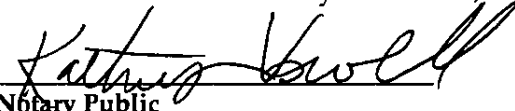
