THE UNDERSIGNED, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

FIRST: The name of this corporation is: The Capsule Group, Inc.

SECOND: This corporation will commence its existence on the date of the filing of these Articles of Incorporation with the Florida Department of State and this corporation will exist perpetually thereafter unless sooner dissolved according to law.

THIRD: This corporation may engage in any activity or business permitted under the laws of the State of Florida.

FOURTH: This corporation is authorized to issue One Hundred (100) shares of common stock to be designated as "common shares". All of said stock will be payable in cash, or payable in property (real or personal), labor or services in lieu of cash, at a just valuation to be fixed by the board of directors of this corporation.

FIFTH: The initial mailing address and principal place of business of this corporation will be 1889 SW 3 Street, Pompano Beach, Florida 33069 with the privilege of having its offices and branch offices at other places within or without the State of Florida.




