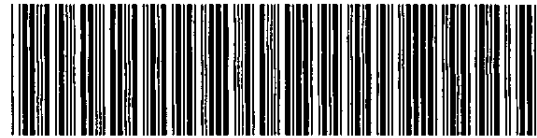

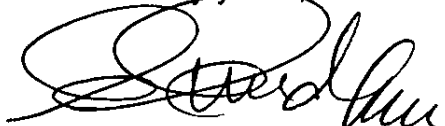

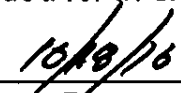
ARTICLE XII.

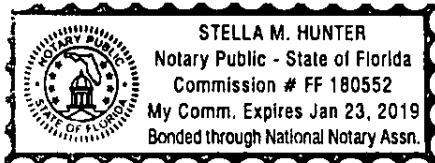
