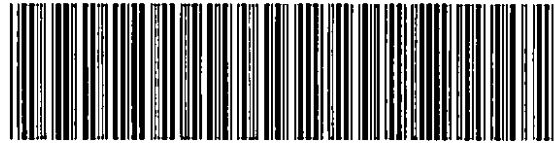

New Business: Secretary Timothy Needl stated he was resigning his position effective October 14, 2019.


The resignation was accepted and new Secretary, Dorsey Lee Guest was presented to the Board and nomination was approved and accepted by the Board by voting.
