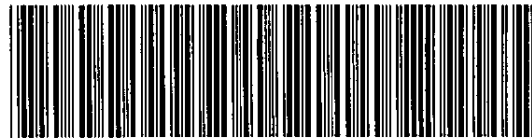

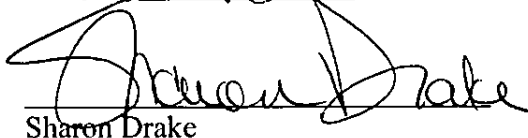
ARTICLE VIII-AMENDMENT TO ARTICLES
