**ARTICLES OF INCORPORATION**

**SINDON02, INC.**

WE, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida and adopt the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation shall be: **SINDON02, INC.** with its principal office address at: 1820 East Hallandale Beach Boulevard, Hallandale Beach, Florida 33009.

**ARTICLE II**

The corporation is organized for the following purposes:

(a) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

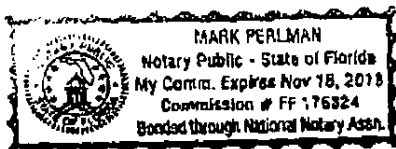
