#### ARTICLES OF INCORPORATION

WE, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida and adopt the following Articles of Incorporation.

## ARTICLE 1

The name of this corporation shall be: SINDON02, INC. with its principal office address att, 1820 East Hallandale Beach Boulevard, Hallandale Beach, Florida 33009.

## ARTICLE II

The corporation is organized for the following purposes:

- (a) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.


