ARTICLES OF INCORPORATION OF THREE LIONS, INC.

CALL SHAW IT SLOWEY.

These Articles of Incorporation are filed pursuant to the Florida Business Corporation Act (the "FBCA").

ARTICLE 1 NAME

The name of the corporation (the "Corporation") is: THREE LIONS, INC.

ARTICLE 2 PURPOSE

The general purpose for which the corporation is organized is to transact any or all lawful business.

ARTICLE 3 PRINCIPAL OFFICE: REGISTERED OFFICE

ARTICLE 8 LIMITATION ON DIRECTOR LIABILITY

No repeal or modification of this Article 6 shall adversely affect any right of or protection afforded to a director of the Corporation existing immediately prior to such repeal or modification.

ARTICLE 9 INDEMNIFICATION

The Corporation shall indemnify and advance expenses to, and may purchase and maintain insurance on behalf of, its officers and directors to the fullest extent pennitted by law as now or hereafter in effect. Without limiting the generality of the foregoing, the By-laws may provide for indemnification and advancement of expenses to officers, directors, employees and agents on such terms and conditions as the Board of Directors may from time to time deem appropriate or advisable.
