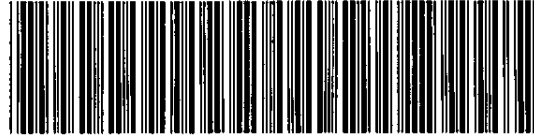

**ARTICLES OF INCORPORATION
OF
BIBLEJOURNEY, INC.**

Pursuant to the Florida Business Corporation Act, the undersigned authorized representative submits these Articles of Incorporation for the purpose of forming **BibleJourney, Inc.** (the "Corporation").

**ARTICLE I
CORPORATE NAME**

The corporate name for the Corporation is **BibleJourney, Inc.**

**ARTICLE II
STREET ADDRESS AND MAILING ADDRESS**

The street address of the initial principal office and the mailing address of the Corporation are the same: 19828 Gulf Blvd, Suite 402, Indian Shores, Florida 33785.

**ARTICLE III
CAPITAL STOCK; NUMBER OF SHARES**

The Corporation is authorized to issue Ten Thousand (10,000) shares of common stock, One Dollar (\$1.00) par value per share, which shall be designated "Common Shares."

**ARTICLE IV
INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The Corporation may indemnify any officer or director of the Corporation, or any former officer or director, to the fullest extent permitted by law.
