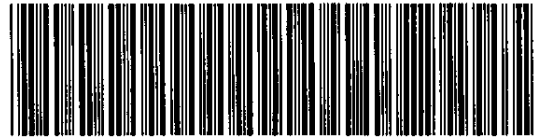

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation for profit under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation is:

**ARTICLE II: EXISTENCE**

The corporation shall have perpetual existence, and shall commence upon the filing of these Articles of Incorporation by the office of the Secretary of State of the State of Florida.

**ARTICLE III: PURPOSE**

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on or to engage in any and all lawful business for which corporations may be incorporated under

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of One (\$1.00) Dollar per share.
