**ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.0202 of the Florida Business Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

**ARTICLE I - NAME**

The name of the corporation is BG Distribution, Inc.

**ARTICLE II - ADDRESS**

The principal office and mailing address of the corporation is 3407 NW 9<sup>th</sup> Avenue, Suite 200, Fort Lauderdale, Florida 33309.

**ARTICLE III - CAPITAL STOCK**

The corporation is authorized to issue One Thousand (1,000) shares of common stock, par value \$0.01 per share.

**ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT**

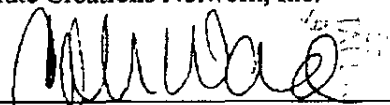
