#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation.

Under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

## ARTICLE 1 - NAME OF CORPORATION

The name of this corporation shall be MICROTECH SERVICES INC.

# ARTICLE 2 - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- A. To engage in every phase and aspect of any business to the public under the laws authorized to render.
