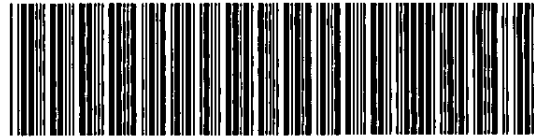

The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 4th day of April, 2017.

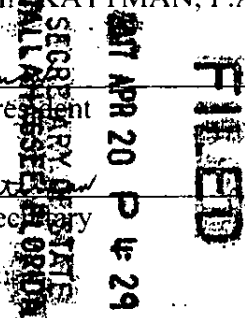

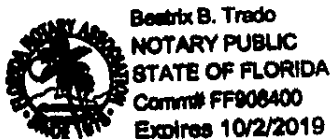
