

ARTICLES OF INCORPORATION

OF

KeyEazy Home Inpections Inc

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation is:

KeyEazy Home Inpections Inc.

ARTICLE II – ADDRESS

The street address of the initial registered office of this corporation is 263 Venetian Way, Sugarloaf Key, Florida 33042. The name of the initial registered agent of this corporation at the aforesaid street address is: Alecheia Williams. The official mailing address will be 263 Venetian Way, Sugarloaf Key, Florida 33042.

ARTICLE III – NATURE OF BUSINESS

The purpose or purposes for which the corporation is organized is to operate a home inspections service permitted under the Law of the State of Florida and of the United States of America; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, or cemetery company, a building and loan association, mutual life insurance association, cooperative association, fraternal benefits society, state fair or exhibition.

The maximum numbers of shares of stock that this corporation is authorized to have outstanding at any one time is Fifty Thousand (50,000) shares of common stock, all of which are to be of One Cent (\$.01) par value each.

Shares may mot be issued until the full amount of the consideration for which the shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and non-assessable and exempt from assessment.
