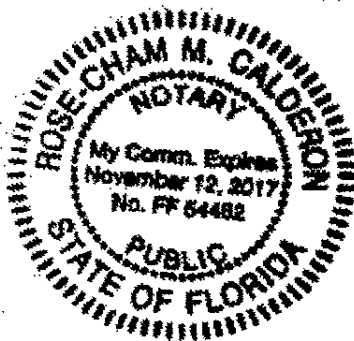
On December 1, 2016, Ozdilek USA, LLC was voluntarily dissolved.
