### ARTICLES OF INCORPORATION

OF

#### BROOKS INTERNATIONAL CANADA HOLDINGS, INC.

THE UNDERSIGNED, acting as sole incorporator under Chapter 607 of the Florida Business Corporation Act (the "Act"), hereby adopts the following Asticles of Incorporation (the "Atticles") for BROOKS INTERNATIONAL CANADA HOLDINGS, INC., a Florida corporation (the "Corporation"):
