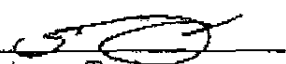
I am the sole Member and Manager of the entity FLORIDA K9 UNLEASHED L.L.C., document number L15000113143 filed on July 2, 2015.

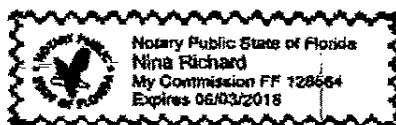
