The undersigned Incorporator, hereby forms a corporation under the Florida Professional Service and Limited Liability Company Act.

ARTICLE I.

CORPORATE NAME

The name of the Corporation (the "Corporation") is Christina Prieto, P.A.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS


ARTICLE X. INDEMNIFICATION
