The undersigned, desiring to form a professional corporation in accordance with the Florida Not For Profit Corporation Act and the Professional Service Corporation And Limited Liability Company Act, adopts the following Articles of Incorporation:

Article 1. Name

The name of the Corporation is: Kenneth Wetcher, M.D., P.A.

Article 2. Initial Principal Office and Mailing Address




