ARTICLE IV: The Company shall be authorized to issue 10,000 shares of common stock, at no par value, 100 of which shall be Class A Voting Shares and 9,900 of which shall be Class B Non-Voting Shares. Other than voting rights, the Class A Voting Shares and the Class B Non-Voting Shares shall all be of a single unidentified class, which shall entitle the holders thereof to the same rights and preferences, including the right to participate in the earnings, equity and distributions of the Company and in the assets of the Company upon its liquidation and dissolution, and to exercise the same rights and impose upon the holders thereof the same duties in all respects.
