WHEREAS, the Board desires to create a continuing resolution for Administrative Officers and to establish a vehicle for regularly updating the list of Administrative Officers, as necessary.

NOW THEREFORE BE IT RESOLVED, that the Administrative Officers listed on Attachment A, hereto are fully empowered, within the delegation of authority from the Board to the President of the University, and his further delegation to each of them, to execute and deliver in the name and on behalf of the University such documents, instruments and agreements as may be required of each such officer, or as each such officer may deem necessary, appropriate or desirable in order to effectuate the foregoing responsibilities;

FURTHER RESOLVED, that annually the President will cause Exhibit A, hereto, to be updated to list the name of each Administrative Officer, and the position he or she holds, as may be empowered under this continuing resolution;

FURTHER RESOLVED, that each of the President, Senior Vice Presidents and Vice Presidents is authorized in the name and on behalf of the University to do and perform any acts whatsoever which such officer may deem necessary, appropriate or desirable in order to effectuate the foregoing responsibility and the University does
