In respect to our corporation, Yundt & McCann Construction Limited, please find enclosed the following documents:

- (i) Completed Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida.
- (ii) A cheque in the amount of \$ 35.00 to cover in full the withdrawal filing fee.

Yundt & McCann Construction Limited is no longer conducting active business operations in Florida. Yundt & McCann Construction Limited continues to hold real estate in Florida for which it does not earn any income. Per our July 17<sup>th</sup> telephone conversation with Sheryl, at your office, she provided to us the following information:

- 1) Yundt & McCann Construction Limited could continue to hold its non-income producing Florida real estate property. The fact that it has filed a Withdrawal of Authority form would not affect its abilities to continue to own this property.
- 2) On the sale of its Florida real estate property the corporation would have to be "Reinstated" to conduct business affairs in Florida. The cost of such a "Reinstatement" would be approximately \$150.00 to the corporation in the year of reinstatement. In the mean time no other filing fees would be required by the State of Florida.
- 3) In filing the enclosed Withdrawal form it will not be necessary to complete the 1998 Profit Corporation Annual Report or pay any of the fees associated with this report.




