ARTICLES OF INCORPORATION OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be Kristina Villaverde Inc. and the initial address of this corporation shall be 7020 Rue Granville, #308B, Miami Beach, FL 33141

ARTICLE II

This corporation may engage in any activity or business permitted under the Laws of the State of Florida.


