ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
LYKINS-SIGNTEK, INC.

THESE ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION (these "Articles of Amendment") of LYKINS-SIGNTEK, INC., a Florida corporation (the "Corporation"), are submitted in accordance with Section 607.1006, Florida Statutes, for purposes of adopting the following amendment(s) to the Articles of Incorporation:

1. The name of the Corporation is "LYKINS-SIGNTEK, INC."
2. The Articles of Incorporation of the Corporation were filed with the Florida Department of State on January 18, 2017 and dated effective as of January 16, 2017 (the "Articles of Incorporation").
3. The text of the amendment to the Articles of Incorporation adopted is as follows:

- (a) ARTICLE 1 IS DELETED IN ITS ENTIRETY AND REPLACED WITH THE FOLLOWING ARTICLE 1:

"ARTICLE 1 – NAME AND PRINCIPAL ADDRESS

The name of this corporation shall be DALY TOOL & DIE, INC., whose principal office shall be located at 8651 PORTSIDE COURT, ORLANDO, FL 32817."


4. The amendment reflected in these Articles of Amendment was adopted on November 13, 2017.
