**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of First Metropolis Corp. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is First Metropolis Corp. (the "Corporation").

ARTICLE II. ADDRESS

ARTICLE IV. PURPOSE

The name and street address of the incorporator is Alejandro F Ponti, 7300 Wayne Avenue, Suite 509, Miami Beach, FL 33141-6475.


ARTICLE IX. BYLAWS


