### ARTICLES OF INCORPORATION OF SANJEET SHAHI, O.D., P.A.

The undersigned subscribor hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation, for the purpose of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Act, Chapter 621, Florida Statutes.

#### ARTICLE I. NAME

1.1. The name of the Corporation shall be: SANJEET SHAHI, O.D., P.A a Florida Corporation.

#### ARTICLE II. PRINCIPAL OFFICE

2.1. The principal place of business of this Corporation shall be: 2900 SE 42nd Street, Gainesville, Florida 32608 and the mailing address of this Corporation shall be: 2805 SE 30th Street, Ocala, Florida 34471. Such addresses may be changed without amending these Articles.

#### ARTICLE III. PURPOSE

- 3.1. This professional service corporation is organized for the following purposes:
