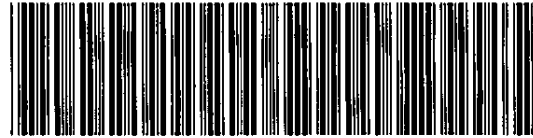

ARTICLES OF INCORPORATION

OF

ARTICLE I- NAME

The name of this corporation is **Miss Guided Girls, Inc.**
