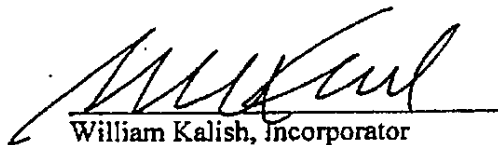
ARTICLE VIII
