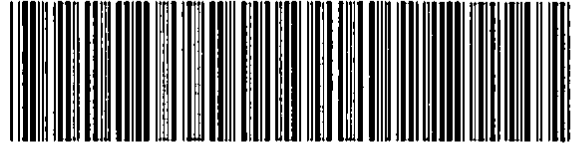

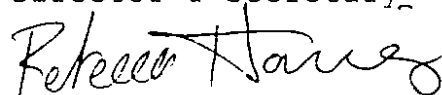

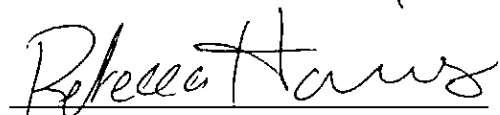
ARTICLE III PRINCIPAL OFFICE AND MAILING ADDRESS

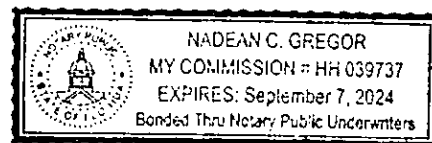
